Office Order

On the recommendation of HP Staff Selection Commission, Hamirpur following candidates are herby appointed as Physical Education Teacher in order of merit purely on contract basis on the fixed salary on Rs.10300+3200 + 100% of the Grade pay per month and annual increase of Rs/-405 after completing one year of services and renewal of contract. The appointees are directed to report for duty in the respective schools of their posting, as shown against their names within the prescribed time, subject to the acceptance and fulfilment of specific terms and conditions in addition to the usual terms and conditions of appointment annexed as annexure -A.

- Since the appointment is being given purely on contract basis the appointee will have to execute a bond on the judicial paper with the Headmaster/Principal of the concerned school where he/she is posted, that he/she has carefully gone through the conditions of the contract appointment and the conditions imposed are acceptable to him. The joining report will be accepted only after the execution of the requisite bond between the Head of the institution and the appointee.
- It will be the personal responsibility of the candidate /individual to inform this office on the proforma enclosed duly countersigned by the Principal / Headmaster of the concerned school that he/she has joined the place of his /her appointment on or before the schedule period failing which his /her appointment shall stand withdrawn on the expiry of the stipulated date and time and he/she will be debarred from appointment.
- That the educational and professional qualification possessed by the candidate will be the same as prescribed by the department for the post of Physical Education Teacher, in the concerned post. The DDO concerned can check this from the departmental website. The head of the school will also ensure that the educational and professional qualification possessed by the candidate is from a recognised University. Necessary verification to this effect is to be made by the head of the concerned school at the time of his/her joining. Duly attested copies of certificates awarded to the candidate by the recognized Universities/Board be kept in the office records.
- 4 That each candidate being offered appointment as Physical Education Teacher will have to ensure that he/she has acquired complete knowledge of latest CCS/CCA conduct rules with in a fortnight from the date of joining duties and will submit an undertaking to this effect in writing to his/her head of school.
- He/she is being posted in non sub cadre area temporarily due to non availability of vacancy in sub cadre area he/she is to serve in sub cadre area as and when vacancy arises in this area. If these specific as well as usual terms and conditions are acceptable to the candidates he /she will report for duty at the institution of his /her posting within fifteen days from the date of issue of these orders along with documents required to be produced as per terms of this order and will execute the requisite bond of contract failing which the offer of appointment shall automatically stand cancelled and the candidate will have no right to claim it.

TERMS AND CONDITIONS OF CONTRACT APPOINTMENT (C&V)

1 The concerned candidate will have to produce the medical fitness certificate from the the area concerned at the time of his /her joining.

2 The candidate concerned shall have to submit a declaration to the effect that if married he/she has only one living spouse. The women candidates will declare that she has not married a person having a living wife.

3 The concerned candidate shall have to produce attested copies of his/her academic/professional qualifications/domicile/date of birth etc.

4 The concerned candidate shall have to produce a character certificate from any gazetted officer to whom he/she is known for last ten years. Before taking joining, original documents of the concerned appointee be got verified by the authority concerned to avoid any discrepancy.

5 The concerned candidate shall have to furnish a declaration to the effect that he/she is not a dismissed employee of any Govt./Semi-Govt. Deptt. /Organization.

6 The appointment may be terminated at any time by a month's notice on either side without assigning any reason.

7 The concerned candidate will have to make an oath of allegiance /faithfulness to the constitution of India.

8 The candidates belonging to SC/ST/OBC etc. Will furnish the requisite certificate on the prescribed format only, issued by the competent authority.

His/her retention in service is subject to his/her character being found satisfactory, which should be got verified by the concerned head of the school within the period of three months.

He /she will have to submit in writing whether he/ she were ever convicted by any criminal court and if so the particulars of the offence and punishment be stated. Failing to disclose the facts he/she will render himself or herself liable to be removed from service without any notice as and when the factual position comes into light.

- 11 The candidate concerned shall have to produce a certificate of his /her being a citizen of India and bonafide candidate of Himachal Pradesh.
- 12 In case the candidate belongs to IRDP family he/she shall have to produce a certificate to this effect from the concerned Block Development Officer.
- 13 In case any of the certificate/information produced /given by the candidate is found false /wrong later on his/her services will be terminated.
- 14 The appointee shall have to serve in the difficult area/sub cadre area for a minimum period of five years.
- 15 It should also be affirmed that concerned candidate must have registered with respective Employment Exchange before attaining the age of forty five years.
