I have the honour to submit that in the instant matter a clarification regarding grant of approved Military Services for the purpose of pay fixation in compliance to H.P. Govt. Deptt. of Personal letter No. PER(AP)-C-B(12)-1/2013 dated 25,2,2019 has been issued to Director Higher Education vide your letter No. EDN-B-C(17)-7/2018 dated 05.10.2019 (copy enclosed), wherein Para 5(ii) of DOP instructions dated 25.02,2019 has further been added and clarified that the "benefit of pay fixation is allowed to Ex-Servicemen by counting their past military service rendered after attaining the minimum age and qualification prescribed for appointment to the service concerned".

It is pertinent to mention here that in view of withdrawing the instructions of dated 30.01.2018, the pay of Ex-Servicemen in this Department was fixed in accordance with Para 5(11) of DOP instructions dated 25.02.2019 which originally states that "the benefit of counting past service rendered in the Armed Force towards pay fixation may be given". In view of this, the Department has approved /revised numbers of cases of various categories of teachers regularized in these posts against quota reserved for Ex-Servicemen before 29.01.2018, allowing them full benefit of approved military service

You are, therefore, requested to please clarify whether to review/re-fix after attaining minimum age. these fixation of pay in accordance with the clarification issued to Director Higher Education on dated 05.10.2019 or not. In the meanwhile, all pending cases of pay fixations have been kept in obeyonce till the yours faithfully. clarification is received.
