
Sir,

I am directed to refer to your letter No. EDN-(SE)-HCS-B-15-2025-Pay fixation, dated 24.09.2025 on the subject indicated above and to say that the matter was taken up with the Finance(Regulation) Department, who has advised as under :-

"Examined, in consultation with the Finance (Pay Revision) Department. It is observed that the Finance (Pay Revision Department) had issued notification dated 27.09.2012 whereby it was ordered that C&V Teachers, Drivers and all Class-IV employees shall continue to get special/additional increment after putting in 20 years of regular service under the HPCS (Category/postwise) Rules, 2012. After the inception of HPCS (RP) Rules, 2022 notified on 03.01.2022 the Rule 14 i.e. the "Overriding effect" of which provide that the provisions of all previous pay rules including the Category/postwise rule, 2012 shall not save as otherwise provided in these rule apply to the cases where the pay is regulated under these rules to the extent they are inconsistent with Pay Rules, 2022."

You are, therefore, requested to take necessary action in the matter accordingly.


