to Class Nursery to Class-1<sup>st</sup> as per NEP,2020.

Sir,

In partial modification to instructions/guidelines issued vide letter of even number dated: 17.12.2024 for adoption of age criteria for admission to Class Nursery to Class-1<sup>st</sup> has been revised as per provisions contained under Section-15 of RTE Act,2009 & Rule-6 of HPRTE Rules,2025, shall be as under :-

- (i) **Balvatika-I (Nursery)** : Child shall be eligible for admission on completion of age 03 years on or before 30<sup>th</sup> September of respective academic year.
- (ii) **Balvatika-II (LKG)** : Child shall be eligible for admission on completion of age 04 years on or before 30<sup>th</sup> September of respective academic year.
- (iii) **Balvatika-III (UKG)** : Child shall be eligible for admission on completion of age 05 years on or before 30<sup>th</sup> September of respective academic year.
- (iv) **Class-I** : Child shall be eligible for admission on completion of age 06 years on or before 30<sup>th</sup> September of respective academic year.

You are, therefore, requested to take further necessary action in the matter accordingly.
