In order to increase enrollment of new voters especially voters in the age group of 18-19 years, worthy District Election Officer, Kangra has directed for organization of a special contact campaign wherein the Booth Level Officers (BLOs) will visit all households door-to-door from April 1, 2019 to April 5, 2019 and cover all left-out voters by filling Form -6. Therefore, by direction of DEO, you are hereby appointed as the District Nodal Officer for monitoring of the door-to-door campaign for voter enrollment from April 1, 2019 to April 5, 2019 in respect of the BLOs belonging to your department across all Assembly Constituencies of District Kangra. List of BLOs of all 15 Assembly Segments of district Kangra is enclosed in PDF form alongwith their contact numbers. You are requested to segregate the BLOs pertaining to your department and collect daily progress report from them in enclosed format. You shall be responsible for submitting daily report for the new voter enrollment done by the BLOs of your department by 4PM daily in the format given below:-

Default in non-submission of the report in timely manner shall be viewed very seriously. In this connection, the provisions of Section 134 of the Representation of People's Act are brought to your notice whereby any act or omission in breach of his official duty in connection with elections has been made a punishable offence under law. Being an election matter, this must be given top priority.
