**Terms and Conditions.**

1. Part-Time Class-IV workers after completing eight (8) years of continuous service as on 31<sup>st</sup> March, 2019 and 30<sup>th</sup> September, 2019 will only be made Daily Wagers. Posts so vacated by such Part Time Workers shall stand abolished.
2. The candidate will have to produce a medical fitness certificate from CMO/MO of the illaqua concerned.
3. The candidate will have to furnish a declaration to the effect that if he/she is married and having one living spouse.
4. The candidate will have to furnish a certificate in proof of his/her date of birth as per criterion as laid down in Rule 7.1 of HPFR Vol-1 and Rule 172 of HPFR 2009 shall be observed.
5. The candidate will have to give in writing whether he /she was ever convicted by any court of law and if so, the particular(s) of the offence and punishment imposed, if failing to disclose the facts will rendered him/her liable to removal him as and when facts come to the light.
6. The candidate will have to take an oath of allegiance / faithfulness to the constitution of India. If information / document supplied by the candidate is found to be incorrect as later stage, in such event it will be the personal responsibility of the candidate and his/her appointment is liable for termination.
7. If the offer of appointment is acceptable to the candidate then he /she should report to his / her place of posting within 15 days from the issue of these orders other wise the offer of appointment shall stand cancelled.
