Dear Sir/Ma'am,

As you are aware the Rights of Children have been acknowledged in the Constitution of India under Fundamental Rights as well as Directive Principles of State Policy. These rights have been broadly categorized into four categories of Survival, Development, Protection and Participation, Education being an important part of children's right to development. Thus providing a safe and secure learning environment for children becomes a collective responsibility of all the stakeholders.

2. Following the judgment given in the Writ Petition (Criminal) No. 136 of 2017 and Writ Petition (Civil) No. 874 of 2017 by the Hon'ble Supreme Court, the Department of School Education & Literacy is in the process of preparing guidelines for fixing the accountability of school management in the matter of safety of children studying in schools. A series of consultations have been held in this regard with various stakeholders including school managements, teachers, students and counselors wherein the need has emerged to have a Display Board with affirmative action on security measures, helpline, emergency numbers and contact persons. Also, under the scheme of Samagra Shiksha, every school (Elementary & Secondary) is required to display a board for which a provision of Rs. 500/- per school has been made.

3. As a follow up on this initiative, a draft School Safety Pledge is forwarded herewith for your comments. The School Safety Pledge is to be put up on a Board or painted on a wall at a prominent place in the School. You are requested to kindly send in your comments to this Department by 09th October, 2019, urgently.

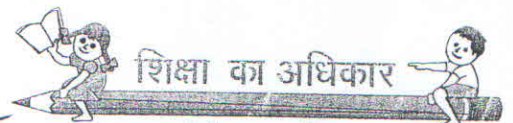
