Dear Sir,

- That I was enrolled in the Army on 15.10.1971 and transferred to pension establishment on 01.11.1999 on completion of 28 years of service.
- That I was appointed for the post of PET vide Office of The District Education Officer Mandi, District Mandi, Himachal Pradesh, in Code 175001, vide letter No EDN MND(III)B-43/2K1(Apptt-9931-35 dated 11 Jun 2001 and joined duties on 16.06.2001 and retired from the service on superannuation on 31.03.2011 while serving with Govt. Senior Secondary School Sadhot, District Mandi (HP).
- That as per Policy of Government of India, I was entitled for counting of my Military Service towards civil services of PETs for purpose of Pay fixation the total military service of 28 years, but inspite of my repeated requests no benefits was released to me and lam suffering huge financial loss.
- In view of the above facts kindly forward the Nominal roll of Ex-Servicemen re-employed in the EDUCATION DEPARTMENT OF HIMACHAL PRADESH since 01 Jan 2001 and their former Military Service was counted/not counted towards Pay Fixation, as per the format given below under RTI Act 2005, at your earliest please to file petition in the competent Court of Law :-


