
**OFFICE ORDER**


The above Centre Head Teachers are admissible to exercise their option (s) for fixation of pay under the provision of FR22 within one month from the date of issue this order.

Copy for information and necessary action is forwarded to:-

1. All the Block Primary Education Officers in Kangra Distt. with the directions that the concerned teacher may be relieved immediately to enable them to join their new place of posting on promotion. **In case of teacher promoted under SC/ ST Category be verified with their original certificate before relieving/joining.** In case the person on promotion does not join his/her duties at the place of posting within the stipulated period i.e. 15 days of issuance of this order, such promotion will be automatically considered to have been forfeited and no need to issue the cancellation orders of the promotion by the Deputy director of Elementary Education. Further he/she will not be considered for the promotion for the next ONE YEAR as per instructions of the Govt. **You are further directed that before relieving the official to join at the new place of posting on promotion it may be ensured that no Departmental Inquiry/Vigilance case is lying pending against said official.** It may also be ensured that left out case, the teacher promoted should not have been promoted earlier, if promoted, they must have completed the debarred period i.e. ONE YEAR. The relieving/joining/forgo in connection with the above order be sent to this office on priority basis duly countersigned by the concerned Block Elementary Edu Officer



**TERMS AND CONDITIONS**

1. He/she will move immediately on the receipt of this order.. However, his/her seniority position in the higher scale will be in order as in the their scale but in case the teacher fails to join his/her order of promotion will be deemed to have been forfeited. In case, the teacher on promotion does not join within 15 days of the issuance of the orders such promotion will be automatically considered to have been forfeited/cancelled and he/she will not be considered nor he/she will eligible for promotion during the next one year as per instructions issued from time to time and if not joined in this stipulated period next junior will be considered for promotion
2. In case any factual error which comes notice of this office at any stage the promotion orders can be reviewed and withdrawn without assigning any notice at any time.
3. The minimum qualification for the post of CHT is JBT/JT/JV for teaching all subjects in primary classes of the schools.

4. **Experience of teaching in primary classes in H.P. for 13 years is essential as JBT/HT combined.**
5. The incumbent shall have to refund the amount so received by him/her in case any factual error comes to the notice of this office the promotion will be withdrawn.
6. The promotion is subject to review if needed be.
7. The pay on promotion may be claimed from the new place of posting after their joining at new place of posting.
8. No leave/extension in joining time will be granted till they join their new place of posting. Leave/extension in joining time on medical ground will be considered only if supported with medical certificate issued by the Medical Board constituted by the Chief Medical Officer.
