Regarding preparation of People Biodiversity Registers(PBRs).

Please refer to the letter No -PCH-HA(1)2/2013-BDA-41412-503 Dated 10 July 2020 from the Director Panchayati Raj which is also address to you and Distt. Panchayat Office letter no Panch.KGR Vividh-10317-31 dated 13/7/2017 on the above cited subject .

As per the directions recieved from the Special Secretary, Panchayati Raj Department to the Govt. of Himachal Pradesh to achieve the target of preparation of 100% PBRs with in the time line fixed for 31/8/2020 . It has been decided that the services of two life science graduates be hired for a group of 5 Gram Panchayat for a period of two months from nearby High school / G.S.S.S or any life science graduate of the Panchayat area who shall collect data and prepare PBRs at Gram Panchayat level in the form of soft copy and submit the same to the State Biodiversity Board . The printing and binding of PBRs shall be done by the Himachal Pradesh State Biodiversity Board as mentioned in the letter. The life science graduates will be paid honorarium, TA/DA&stationery etc charges @ Rs. 10000/- per Panchayat for non tribal areas.

You are therefore, requested to start identifying and hiring the services of these two life science graduates in the group of 5 Gram Panchayats as per the requirment of your Development Block with in two days under intimation to undersigned and the Directorate of Panchayati Raj H.P Shimla. These life science graduates be imparted training immediatly in coordination with the technical experts of the State Biodiversity Board and the process of preparation of PBRs will be completed in compliance to the directions issued by Hon'ble National Green Tribunal .
