TERMS AND CONDITIONS

1. He/she will move immediately on the receipt of this order. However, his/her seniority position in the higher scale will be in order as in the their scale but in case the teacher fails to join his/her order of promotion will be deemed to have been forfeited. In case, the teacher on promotion does not join within 15 days of the issuance of the orders such promotion will be automatically considered to have been forfeited/cancelled and he/she will not be considered nor he/she will eligible for promotion during the next one year as per instructions issued from time to time and if not joined in this stipulated period next junior will be considered for promotion

2. In case any factual error which comes notice of this office at any stage the promotion orders can be reviewed and withdrawn without assigning any notice at any time.
