Please find enclosed the copy of Govt. letter's No. PER (AP)-C-B(19)-03/96-Vol-VII dated 29.01.2018 & No. PER(AP)-C-B(12)-1/2013 dated 01.04.2021 (copies enclosed) vide which the pay of ex-servicemen was fixed as per minimum qualification.

In this context, it is intimated that as per R&P rules for TGT's the essential academic and professional qualification for the post of TGT is B.A./B.Sc./B.com and B.Ed and TET (Teacher Eligibility Test). The benefit of approved military service to the Ex-servicemen (who were regularized after 29.01.2018) towards pay fixation is to be given from the date of passing of TET as per R&P rules.

Therefore, you are directed to submit pay fixation proposals in r/o Ex-servicemen on the basis of passing of Teacher Eligibility Test.
