OFFICE ORDER

Consequent upon the transfer under 5% quota from GHS Choori Distt. Chamba to GHS Jarot u/c GSSS Amlela Distt. Kangra vide Directorate of Elementary Education office letter No. EDN-H(III)B(6)-CWP No. 9901/2024 dated 16.01.2025, Sh. Gaurav Singh Guleria, PET, posted at GHS Choori Distt. Chamba, is hereby adjusted on transfer at GHS Jarot u/c GSSS Amlela Distt. Kangra against vacancy due to large enrollment of students under 5% quota without TTA/JT, subject to the acceptance of all codal terms and conditions given below:-

- 1. Transfer in place of deputation shall be made in the event of vacant post in the District where transfer is ordered. Inter district transfer shall be made once in the entire service period.
- 2. Transfer of the married women teachers under 5% quota are exempted from the condition of Five years of service in the present district.
- 3. That the incumbent concerned must have completed at least Five years of service in the cadre of present district except in case of married women and on medical grounds approved by the competent authority. In transfers on mutual basis there will not be limit of minimum stay, even regular and contract teachers could be transferred on mutual basis. For more than 60% handicapped candidates there will not minimum stay limit.
- 4. After transfer under 5% quota the concerned teacher will be allotted seniority in the second district from the date of joining in the second district and he / she shall placed at the bottom of seniority of the district where he/she has joined on transfer.
- 5. No TA/DA shall be admissible to the incumbent concerned at the time of transfer under 5%
- 6. In the event of inter district transfer the incumbent will have to loose his seniority in the previous district.
- 7. After transfer under 5% quota the request for repatriation to the parent district will not be considered.
- 8. Order shall be implemented on the availability of the quota under 5% in the inter District transfer policy.
- 9. The teacher concerned shall be relieved as and when the Dy. Director of Education of the District (from which teacher concerned is to be transferred), issues his/her posting orders to the Dy. Director of Education from where the transfer orders are to be issued / released.
