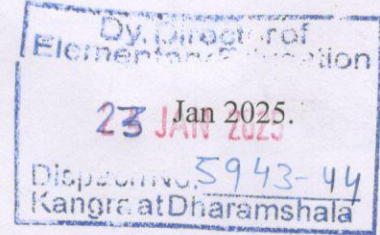

**OFFICE ORDER**

Consequent upon the transfer under 5% quota from **GMS Chouli u/c GSSS Rakkar(Dehra) District Kangra to District Sirmour**, vide the Directorate of Elementary Education H.P. Shimla office letter No. EDN-Ele(III)B(6)CWP No.12552/2024 Dated 15.01.2025, **Sh. Tiwari Sharma, Shastri, GMS Chouli u/c GSSS Rakkar District Kangra is hereby adjusted on transfer at GSSS-Bharog Baneri District Sirmour, due to large enrolment of students, against vacancy without TTA/JT, under 5% quota, in the matter of CWP No. 12552/2024 titled as Tiwari Sharma Vs State of HP**, subject to the acceptance of all codal terms and conditions given below :-

1. Transfer shall be made in the event of availability of vacant post in the District cadre where transfer is ordered, which shall be made once in the entire service period.
2. Transfer of married women teachers under 5% policy are exempted from the conditions of 05 years of service in the present district.
3. That the incumbent (s) concerned must have completed at least five years of service in the cadre of present District except in case of married women and on medical grounds approved by the competent authority.
4. He\she shall be placed at the bottom of seniority of the cadre as on 31<sup>st</sup> December of the year.
5. After availing transfer under 5% quota the request for repatriation will not be considered.
6. No TA/DA joining time shall be admissible to the incumbent concerned at the time of transfer under 5% quota
7. Transfer order shall be implemented on the availability of the quota under 5% in the inter district transfer policy.
8. The teacher(s) concerned shall be relieved as and when the Dy. Director of Education of district (Form which the teacher concerned is to be transferred), issues his/her posting orders to the Deputy Director of Education from where the transfer orders are to be issued /released.
9. For Transfer on mutual basis there will be no minimum stay condition, even contract and regular employees could be transferred on mutual basis, but they will have to loose their seniority.
