Whereas, many petition were filed in the Hon'ble High court of H.P by those C&V teachers who were appointed under PARA Teacher Policy-2003 for grant of minimum of revised pay scale of Rs.10300+3200 w.e.f. 01.04.2007 to 31.03.2010 on the analogy of CWP No. 4954of 2012 titled as Madan Lal and others Vs State of H.P. & Ors and other connected matters, decided on 07.11.2012, and CWPOA7661 in OA No. 2641/2019 titled as Pushap Raj Khimta & Others Vs State of HP & Others decided by Hon'ble High Cour of HP on dated29.06.2022. The Hon,ble Ligh court of HP in these petitions has directed to consider a decide the cases of the petitioners in the light of judgment passed in Madan Lal,s and Pushap Raj Khimta's case.

And whereas, a similar matter of Para Teacher in CWPOA No. 7661/2022 in OA No. 2641/2019 titled as Pushap Raj Khimta & Others Vs State of H.P. & others was decided by the Hon'ble High court of H.P. on dated 29.06.2022 and the said judgment has been stand implemented vide office No. EDN-H(2)7661/2022-CC dated 20.04.2023 and the petitioners (Para C&V) have been granted benefit of minimum of revised pay scale of Rs. 10300-34800 with appropriate grade pay of the post w.e.f. 01.04.2007 to 31.03.2010, subject to the final outcome of the LPA filed in the Hon'ble High court of H.P. vide e-filing No. EC-HPHC01-00637-2022 dated 06.02.2023 with the condition that in case the outcome of LPA comes in favour of the department, the petitioners are bound to refund the amount of arrear so paid to them.

And whereas, the matter of grant of benefit of revised pay scale to the petitioners whose case were decided by the Hon'ble High court of H.P. on the analogy of CWP No. 4954/2012 titled as Madan Lal & others Vs state of HP & ors and CWPOA No.7661/2022, in OA No. 2641/2019 titled as Pushap Raj Khimta & Ors Vs State of H.P. was taken up with the Government and the Government vide letter No.EDC-C-B (15)-14/2020 dated20.08.2023 has directed to implement the judgment /order in favour of the petitioners (Para Teachers)in personam, on the analogy of Madan Lal and pushap Raj Khimta's cases, subject to the final outcome of further legal remedy, if any being exercised by the state.

Now therefore, in view of the above facts and circumstances the following petitioners, whose cases have also been decided by the Hon'ble High court of H.P. on the analogy of CWP No. 4954/2012 titled as Madan Lal & others Vs state of HP & ors and CWPOA No.7661/2022, in OA No. 2641/2019 titled as Pushap Raj Khimta & Ors Vs State of H.P & Ors are hereby granted the benefit of minimum of the revised pay scale of Rs. 10300-34800/-with appropriate grade pay of the post which works 13500/- (consolidated) as admissible to contract (C&V Teachers) in personam w.e.f. 01.04.2007 to 31.03.2010, subject to the final outcome of the LPA with the condition that in case the outcome of LPA comes in favour of the Department, the petitioners are bound to refund the amount of arrear so paid to them.
