OFFICE ORDER

Consequent upon the selection in the counseling held in this office, following candidates are hereby appointed as Language teachers (Ward of Ex-Servicemen) in order of their respective merit purely on contract basis on the fixed salary on Rs/- 10300 with Grade pay Rs/-3200+ 150% of Grade Pay and annual increase of Rs/-405 after completing one year of services and renewal of contract. The appointees are directed to report for duty in the respective school of their posting, as shown against their names within in the prescribed time, subject to the acceptance and fulfillment of the following specific terms and conditions in addition to the usual terms and conditions of appointment annexed as annexure-A.

- Since the appointment is being given purely on the contract basis the appointee will have to execute a bound on the judicial paper with the Principal/Headmaster concerned school where She/he is posted, that He/She has carefully gone through the conditions of the contract appointment and the conditions imposed are acceptable to him. The joining report will be accepted only after the execution of the requisite bond between head of the institution and the appointee.
- It will be the personal responsibility of the candidate/individual to inform this office on the proforma enclosed duly countersigned by the concerned Principal/Headmaster of their school that He/She has joined the place of his /her appointment on or before scheduled period, failing which his /her appointment shall stand withdrawn on the expiry of stipulated date and time and he/she will be debarred from appointment.
- That the educational and professional qualification possessed by the candidate will be the same as prescribed be the Department for the post of Language Teacher. The head of the school will also ensure that the educational and professional qualification possessed by the candidate is from a recognized university, before the joining report is accepted. Necessary verification to this effect is to be made by the head of concerned school at the time of his/her joining. Duly attested copies of certificates awarded to the candidates by the recognized Universities/ Board are to be kept in the office records. Regarding eligibility and R&P rules, the DDO concerned can check it from the website of Department of Elementary Education Shimla HP.
- That each candidate being offered appointment as Language Teacher will have to ensure that he/she has acquired complete knowledge of the latest CCS/CCA conduct rules with in a fortnight from the date of joining duties and will submit an undertaking to this effect in witting to his/her head office /school.
- He/She is being posted in non-sub cadre area temporarily due to non availability of vacancy in sub cadre area. He/she is to serve in sub cadre area as and when vacancies arises in this area if those specific as well as usual term and conditions are acceptable to the candidates he/she will report for duty at the institution of his/her posting within **fifteen** days from the date of issue of these orders along with documents required to be produced as per terms of this order and will execute the requisite bond of contract failing which the offer of appointment shall automatically stand cancelled and the candidate will have no right to claim it.

TERMS AND CONDITIONS OF CONTRACT APPOINTMENT(C&V)

- 1 The concerned candidates will have to produce the medical fitness certificate from the CMO/MO of Distt./area concerned at the time of his/her joining.
- 2 The candidate concerned shall have to submit a declaration to the effect that if malfried, he/she has only one spouse living. The women candidate (s) will declare that she has not married a person having a living wife.
- Concerned candidate shall have to produce attested copies of his/ her academic/ professional 3 qualification/ domicile/ date of birth etc.
- The concerned candidates shall have to produce a character certificate from any gazetted officer to 4 whom he/she is known for the last 10 years.
- Before taking joining original documents of concerned appointee be got verified by the authority 5 concerned to avoid any doubt.
- Concerned candidates shall furnish a declaration to the effect that the he/she is not a dismissed 6 employee of any Govt. Semi Govt./ Deptt./Organization.
- Appointment may be terminated at any time by a month's notice on either side without assigning 7 any reason.
- The concerned candidate will have to make an oath of allegiance / faithfulness to the constitution of 8
- The candidate (s) belonging to SC/ST/OBC etc. will furnish the parental certificate on the prescribed 9 format issued by the competent authority.
- His/ her retention in service is subject to his /her character and antecedents being found satisfactory. 10 Which should be got verified by the concerned head of the school within the scheduled period of three months alongwith his /her qualification documents.
- He/She will have to give in writing whether he/she was ever convicted by the criminal court and if 11 so the particulars of the offence and punishment be stated. Failing to disclose the facts he /she will render himself/ herself to be removed from service without any notice as and when the factual facts comes to light.

- The candidates concerned shall have to produce the certificate of his /her being a citizen of India and bonafide resident of this district.
- The academic and professional certificates of the candidate must be got verified from the concerned 13 board/University by the DDO concerned, immediately after joining, necessary entry to this effect be made in the service book of the concerned official, under intimation to this office.
- In case the candidate belongs to IRDP/BPL family he /she shall have to produce a certificate to this 14 effect from the concerned BDO of the Area.
- In case of any of the certificate / information produced given by the candidate is found false /wrong 15 , later on his/ her services will be terminated .
- 16 The appointee shall have to serve in the difficult area for a minimum period of five years.
- 17 In case any appointment made against PTA teacher, it will be in consistence with the PTA policy.
