Office Order

Consequent upon the counselling held in this office, following(PH) candidates are herby appointed as Language Teacher in order of merit, purely on contract basis on the fixed amount, equal to 60% of the first cell of the applicable level of the pay matrix of the corresponding cadre of employees, appointed/working on regular basis, and annual increase of 3% after completing one year of services and renewal of contract. The appointees are directed to report for duty in the respective school of their posting, as shown against their names within in the prescribed time, subject to the acceptance and fulfilment of the following specific terms and conditions in addition to the usual terms and conditions of appointment annexed as annexure-A.

- Since the appointment is being given purely on contract basis the appointee will have to execute a bond on the judicial paper with the Headmaster/Principal of the concerned school where he/she is posted, that he/she has carefully gone through the conditions of the contract appointment and the conditions imposed are acceptable to him. The joining report will be accepted only after the execution of the requisite bond between the Head of the institution and the appointee.
