

OFFICE ORDER

Consequent upon the selection in the interview held in this office, further directions issued vide Directorate of Elementary Education office letter No-EDN-H (Ele.-III) -01/2021-C&V- apptt. Dated 29.09.2022 on priority basis to comply with the directions passed by the Hon'ble High court in CWP No. 6661/2021, titled as SMC VS State of HP & O.s, following candidates are hereby appointed as Shastri, in order of their respective merit purely on contract basis on the fixed salary equal to 60% of the first cell of the applicable level of the pay matrix of the corresponding cadre of employees, appointed/ working on regular basis. The appointees are directed to report for duties in the respective schools of their posting, as shown against their names within in the prescribed time, subject to the acceptance and fulfilment of the following specific terms and conditions in addition to the usual terms and conditions of appointment annexed as annexure-A.

1 Since the appointment is being given purely on the contract basis the appointee will have to execute a bond on the judicial paper with the Principal/Headmaster concerned school where She/he posted, that He/She has carefully gone through the conditions of the contract appointment and the conditions imposed are acceptable to him. The joining report will be accepted only after the execution of the requisite bond between head of the institution and the appointee.

2 It will be the personal responsibility of the candidate/individual to inform this office on the proforma enclosed duly countersigned by the concerned Principal/Headmaster of their school that He/She has joined the place of his /her appointment on or before schedule period, failing which his /her appointment shall stand withdrawn on the expiry of stipulated date and time and he/she will be debarred from appointment.

3 That the educational and professional qualification possessed by the candidate will be the same as prescribed by the Department for the post of Shastri Teacher. The head of the school will also ensure that the educational and professional qualification possessed by the candidate is from a recognized university, before the joining report is accepted. Necessary verification to this effect is to be made by the head of concerned school at the time of his/her joining. Duly attested copies of certificates awarded to the candidates by the recognized Universities/ Board be kept in the office records. **The qualification for the post of Shastri Teacher Eligibility Test conducted by HPSSSB Hamirpu /HP. Board of School Education Dharamshala".**

4 That each candidate being offered appointment as Shastri Teacher will have to ensure that he/she has acquired complete knowledge of the latest CCS/CCA conduct rules with in a fortnight of the date of joining duties and will submit an undertaking to this effect in writing to his/her head office /school.

5 He/She is being posted in non-sub cadre area temporarily due to non availability of vacancy in sub cadre area. He/she is to serve in sub cadre area and when vacancies arises in this area if those specific as well as usual term and conditions are acceptable to the candidates he/she will report for duty at the institution of his/her posting within fifteen days from the date of issue of these orders along with documents required to be produced as per terms of this order and will execute the requisite bond of contract failing which the offer of appointment shall automatically stand cancelled and the candidate will have no right to claim it.


- 1 The Director of Elementary Education H.P. Shimla-1 for information please.
- 2 The Principal/Headmaster of the concerned schools with the directions that before accepting the joining reports of the candidates a bond on the judicial paper (in triplicate) is required to be executed between the head of the institution and the contract appointee as per specimen copy enclosed. Original copy of the bond will be retained in the office of the school, second copy is to be handed over to the appointee and third copy will be forwarded to this office along with joining report. The joining of appointee will be treated from the date of signing the bond.

TERMS AND CONDITIONS OF CONTRACT APPOINTMENT(C&V)

- 1 The concerned candidates will have to produce the medical fitness certificate from the CMO of Distt. concerned at the time of his/her joining.
- 2 The candidate concerned shall have to submit a declaration to the effect that if married, he/she has only one spouse living. The women candidate (s) will declare that she has not married a person having a living wife.
- 3 Concerned candidate shall have to produce attested copies of his/ her academic/ professional qualification/ domicile/ date of birth etc.
- 4 The concerned candidates shall have to produce a character certificate from the competent authority.
- 5 Concerned candidates shall furnish a declaration to the effect that the he/she is not a dismissed employee of any Govt. Semi Govt./ Deptt./ Organization.
- 6 The concerned candidate will have to make an oath of allegiance/faithfulness to the constitution of India.
- 7 The candidate (s) belonging to SC/ST/OBC etc. will furnish the parental certificate on the prescribed format issued by the competent authority.

- 8 His/ her retention in service is subject to his /her character and antecedents being found satisfactory. Which should be got verified by the concerned head of the school within the scheduled period of three months.
- 9 He/She will have to give in writing whether he/she was ever convicted by the criminal court and if so the particulars of the offence and punishment be stated. Failing to disclose the facts will render himself/ herself to be removed from service without any notice as and when the factual facts comes to light .
- 10 The candidates concerned shall have to produce the certificate of his /her being a citizen of India.
- 11 **The academic and professional certificates of the candidate must be got verified from the concerned board/University by the DDO concerned, immediately after joining, necessary entry to this effect be made in the service book of th e concernd official, under intimation to this office.**
- 12 In case of any of the certificate / information produced given by the candidate is found false /wrong , later on his/ her services will be terminated .
- 13 The appointee shall have to serve in the difficult area for a minimum period of five years.
- 14 In case any appointment made against PTA teacher, it will be in consistence with the PTA policy.
- 15 If at any later stage any factual error come into notice the services will be terminated with prior notice
