

2. All the concerned Principals/ Headmasters GSSS/ GHS are therefore directed to implement the above transfer(s) adjustments(s) orders keeping in view the conditions given below:-

- i. While regulating/implementing transfers of teachers, the norms and standards for providing teachers in a school as contained under Sr. No. 1 (b) in the schedule of RTE Act 2009 be compiled with strictly. In case of any violation of these instructions, you will be entirely responsible being an implementing and appointing authority. However before implementing these transfer order it may be ensured that the school does not remain without teacher.
- ii. **In case of contract teachers, transfer orders may not be implemented.**
- iii. In case of transfer on mutual basis, in condonation of short stay, willingness of the concerned teachers be obtained by the Principal/Headmaster/Incharge/HOD before relieving him/her. In case he/she is not willing for this transfer, then he/she may not be relieved and the case may be referred back alongwith his/her written unwillingness.
- iv. In case of the transfer on vice/versa basis the following points may be examined in r/o the transferee.

- a. Whether he/she has more than two years of service left
- b. Whether as per his/her service record, he/she does not suffers from any physical handicapped/serious medical problem.
- c. Whether he she served in a tribal/hard area before (in case the transfer is being proposed to a tribal/hard area.)
- d. These transfer orders should meet all the conditions mentioned above. Otherwise the transfer orders may be referred back to this office.
