Subject: - Regarding production/ updation of Aadhar Cards of students.

Sir,

During the scrutiny of demands received in this Directorate, under various State Sponsored Scholarship Schemes, it been observed that the Aadhar numbers have not been provided by most of the Deputy Directors against the names of the proposed beneficiaries.

Here it is informed that production of Aadhar number of the beneficiary is mandatory in all the incentive schemes run by the Government where Direct Benefit Transfer (DBT) is involved. All the Deputy Directors are, therefore, directed to expedite the process of Aadhar enrolment of students initiated by the department in collaboration with Samagra Shiksha and ensure that all the students are enrolled for Aadhar as soon as possible.

Till the time Aadhar is assigned to the child, the benefit under the Scheme shall be given to such children subject to production of the following documents, namely:-


- (a) If the child has been enrolled after attaining the age of five years (with biometric collection), his Aadhar Enrolment Identification slip, of bio-metric update identification slip; and
- (b) Any one of the following documents namely:-
 - i. Birth Certificate; or Record of birth issued by the appropriate authority or
 - ii. School Identity card, duly signed by the principal of the School, containing parents' names and Bank Passbook with photograph; or
 - iii. Certificate of identity having photo of such students issued by the Headmaster or Principal of school under official seal of the school.
- (c) Any one of the following documents as proof of relationship of the beneficiary with the parent or Legal Guardian as per the extant Scheme guide lines , namely;
 - i. Birth Certificate; or Record of birth issued by the appropriate authority or
 - ii. Ration card; or

- iv. Ex-Servicemen Contributory Health Scheme (ECHS) Card; or Employees State Insurance Corporation (ESIC) Card or Central Government Health Scheme (CGHS) Card; or
- v. Pension Card; or
- vi. Army Canteen Card; or
- vii. Any Government Family Entitlement Card; or
- viii. Any other document as specified by the Department :

Provided further that the above documents shall be checked by an Officer specially designated by the department for that purpose.


Above directions may be circulated to all the Block Elementary Education Officers and Heads of the Institutes under your control for further necessary action so that availability of Aadhar Card/ number, with all the students studying in Government run schools could be ensured.

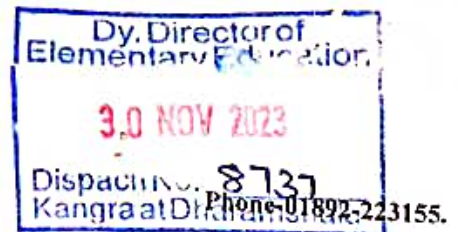
