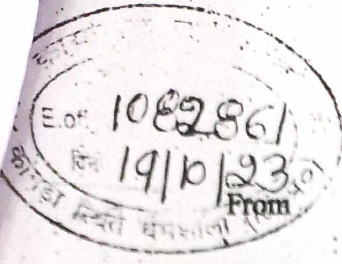

Respected Sir,

Please refer to this Ministry's letter dated 28.07.2023 and regarding conduct of Aadhaar based biometric authentication of officials, Head of Institution as well as beneficiaries, to weed out fraudulent elements from the systems.

2. The drive was initially concurred to complete in one month with the help of NIC-NSP, CSC-SPV and State functionaries working as State and District Nodal Officers for Scholarship Schemes of Ministry. A significant success has been achieved by the State/UT in the drive. The Ministry was quite generous to extend the timeline as per the demand of the States/UTs submitted during the review meetings conducted through VC. Considering the functional requirements, the timelines was extended by the Ministry at four occasions and the last extended timelines is expiring on 19.09.2023 for applicants and on 22.09.2023 for revalidation of application by SNOs.

3. The issues have been reviewed by the Ministry and it has been observed that adequate opportunity have been provided to all stakeholders to complete the bio authentication drive. The specific request for students who left their institutions for pursuing higher studies or due to professional engagements were also attended by the Ministry by providing specific interventions for such applicants through NSP platform. Moreover, in cases wherein the applicants could not complete their bio auth due to data mismatch, death cases, closure of institutions etc, the SNOs have been requested to compile and furnish the details to this Ministry in a prescribed format. The decision in such specific cases will be communicated in due course.

4. Since, the Ministry has to proceed further for disbursement of Scholarship to those applicants who completed their bio auth successfully, it has been decided that no further extension for bio authentication shall be granted beyond 22.09.2023. This has already been communicated to State Nodal Officers in routine reviews taken by the Ministry. I would be grateful if you could direct the SNOs to cover all eligible left out students as per the latest time frame provided (copy enclosed). Moreover, the INO/HoI and DNO has to complete the verification of bio authenticated applications in given time frame.




