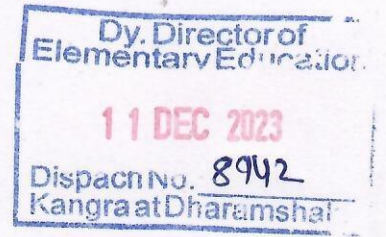

All the Principal/Headmasters of above mentioned school are hereby directed that regularization to the petitioners be allowed after verification of the record that the concerned petitioner has completed three years continuous service (without break) on contract basis as on 31-03-2018 and the consequential benefits regarding monetary benefits to the petitioners will be released as per Hon'ble Court order in Ex. Pet No. 86/2023 dated 13-09-2023 i.e. 40% of arrears payable according to pre-revised scale may be paid by 31-12-2023 and remaining 60% arrears in two equal annual installments may be paid by 31-12-2024 and 31-12-2025 by calculating difference of pay the petitioners on the basis of pre-revised scale for the period from 01-04-2018 till the earlier date of regularization by the State.
