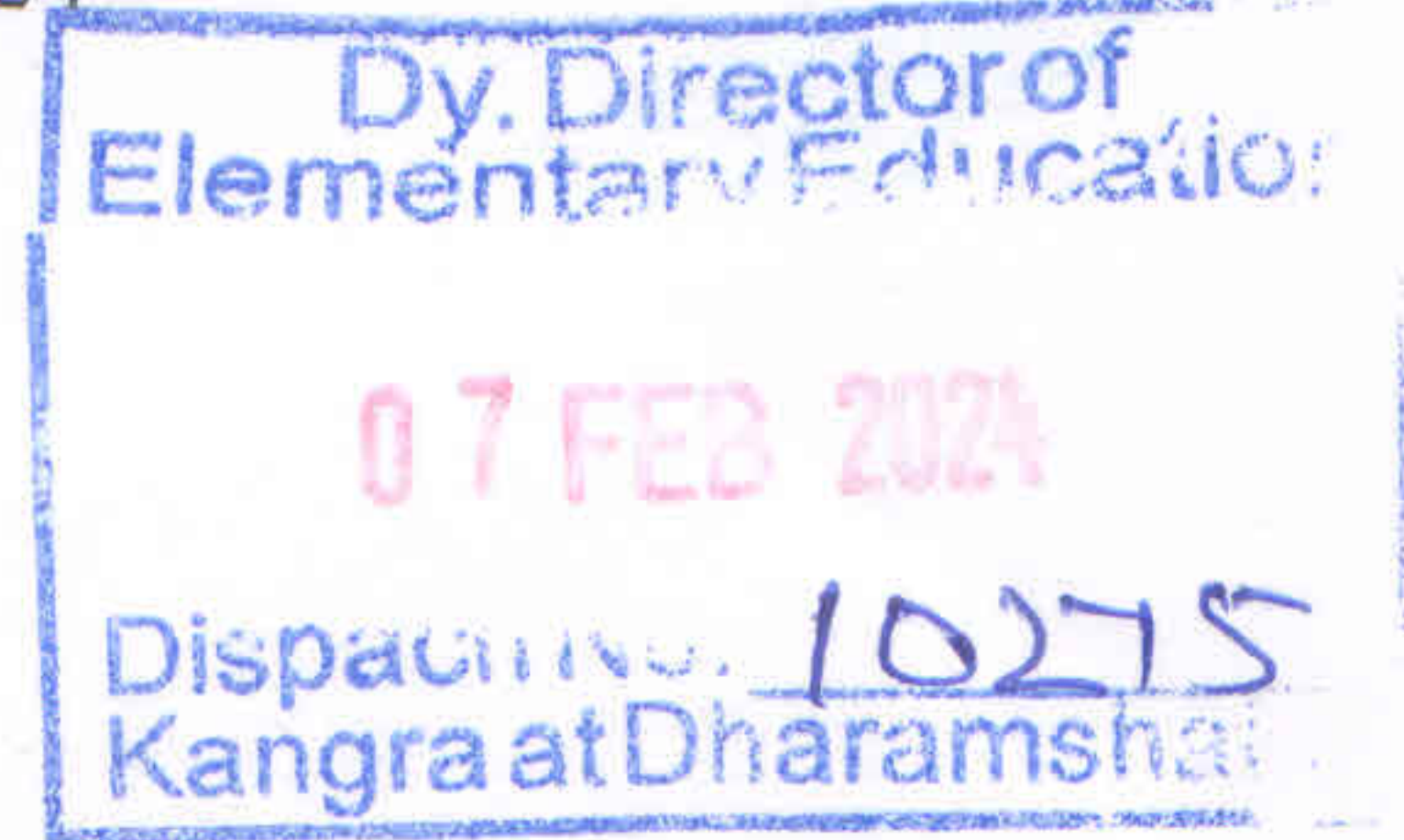

Please provide the following information under section 2(f) and 2(j) of the RTI act:

1) The full name, DOB, permanent area of residence of those TGT NM teachers in Educational Blocks- Nurpur, Jawali, Raja Ka Talab, Fatehpur, Indora, Kotla who have never served or completed their normal tenure in hard/sub cadre or tribal area in their career.

2) The date of joining of TGT NMs in their present- middle, high or senior secondary schools of working, with the details(Date of joining and leaving the previous schools while mentioning educational block and tehsil name) of their previous school of serving.

NOTE: I am serving in tribal area of HP at Distt Chamba and my tenure there is over and I am going to file a Court case at High Court, Shimla for transfer to soft area acco to transfer policy of govt of HP 2013.

I do not know the names ,details of persons who have not served in hard or tribal areas of HP ever and serving in soft areas for long and this is not available in public domain and nobody is telling me this exactly. I am also a govt teacher TGT NM itself. So equality must prevail in serving at hard/tribal areas of state.
